Ukrainian refugees to live on same terms as EU citizens in Ireland

The Ukrainian crisis could create as many as one million refugees, with up to 20,000 arriving in Ireland. Refugees fleeing the war in Ukraine will receive a special status allowing them to work and live in Ireland on the same terms as EU nationals, Foreign Minister Simon Coveney has said. He further said that "We have already announced a €10million humanitarian package and I expect we will do a lot more than that. Last week, Ireland lifted all visa requirements for Ukrainians wishing to enter the country as an emergency measure. Ukrainians arriving in Ireland without a visa have 90 days to "regularise their position".

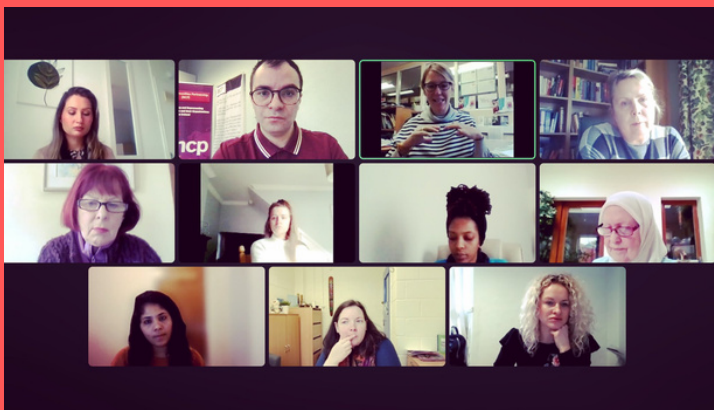

MIGRANT JOB FAIR 2021

The Migrant Job Fair is an annual event organized by NCP to create an opportunity for migrants to access direct information and support, connect with employers, recruiters and relevant organisations. In November 2021 we hosted our first Virtual Job Fair. Each organisation had 15/20 minutes to introduce their work, simultaneously a representative from their organisation answered questions from the attendees through the Q/A window. The companies were: Salesforce, Janssen Sciences Ireland, Oracle, DIAGEO, Boston Scientific, Indeed, PayPal, Public Jobs & Mr. Price. We were honoured to have the Minister of Children, Equality, Disability, Integration and Youth- Roderic O'Gorman give an introductory speech to commence the programme. There were a total of 355 people registered for the event, and 178 attended the event.

SIRIUS Policy Network on Migrant Education

NCP was very happy to be part of & support SIRIUS Policy Conference titled: Sustainable and Impactful Policy Change for Inclusive Education for Migrants. The Conference was in Brussels in hybrid format on 10th of February followed by General Assembly on the 11th. 27 partners were present from 19 different countries.
